Dear Supervisor DeSena and North Hempstead Town Board:

I am writing in support of Southern Land Company's proposed environmental remediation and multifamily housing project located at 145 West Shore Road.

As a Town of North Hempstead resident, I am wary of any new developments that could disrupt our special way of life here. That said, I am a firm believer in a cleaner, greener, and safer Port Washington. That is why I am proud to be in full support of the restorative and exciting project that Southern Land Company has planned.

I know first-hand the potential this property has for contributing to an otherwise idyllic shoreline. This undeveloped parcel deserves to be transformed into a productive, beautified addition to the community. As is, it is not contributing to our landscape, it is affecting the environment, and it encourages unregulated activity that does not benefit our beloved community.

I fully support Southern Land Company's extensive plan to completely remediate this property and turn it into a recreational, publicly accessible area that adds to what makes Port Washington such an amazing place to call home. For instance, Southern Land Company plans to build a 700-foot-long promenade along Hempstead Harbor that anyone can enjoy. I see absolutely no downside to this project.

Southern Land Company has proven to be transparent and receptive in their ongoing, wide-ranging discussions with more than 20 community groups in Port Washington.
